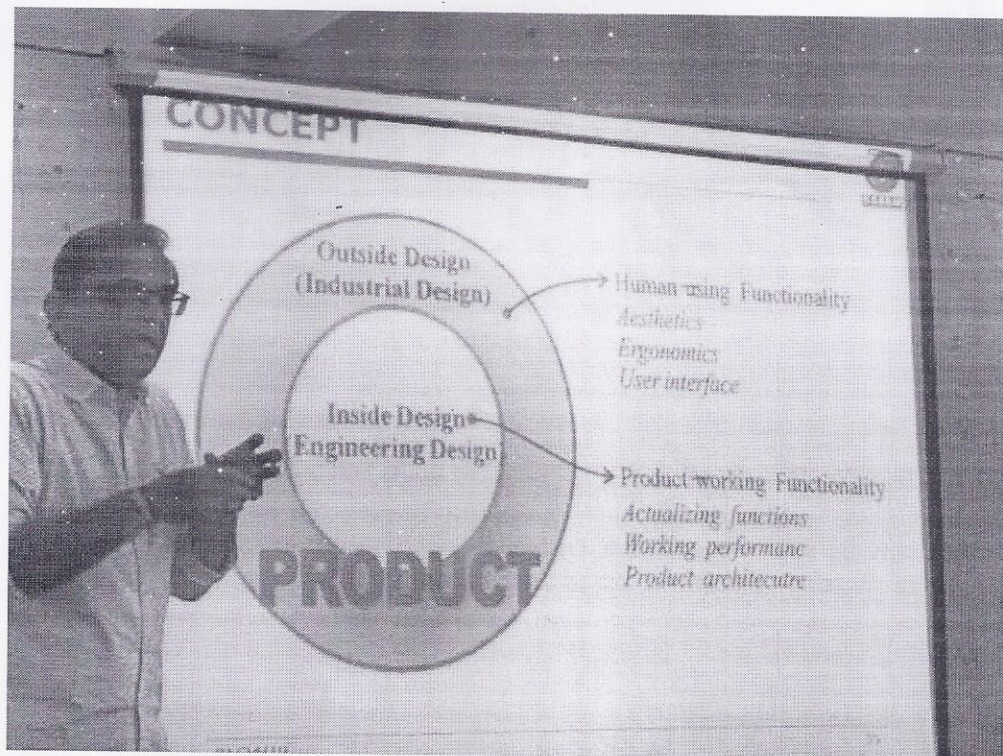
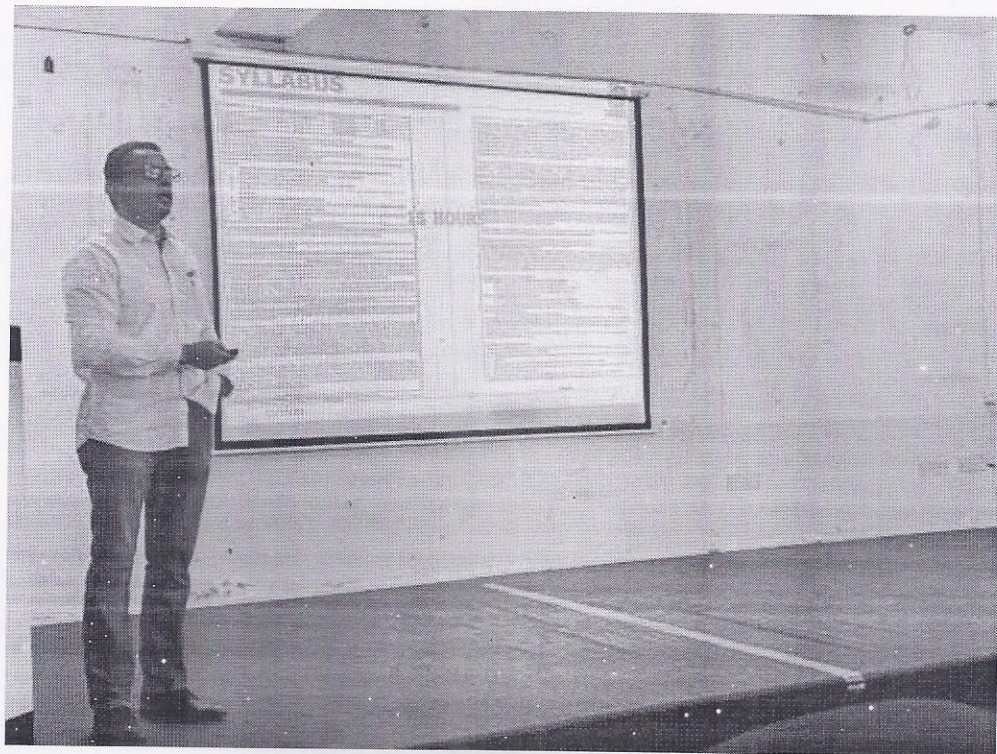
OBJECTIVES OF THE LECTURE:

REPORT




